## **Job Purpose:**

Undertake the cleaning of designated areas within the school, to ensure that they are kept in a clean and hygienic condition. Work will entail regular and one-off cleaning tasks and duties as directed by the Site Services Officer/School/Trust.

#### Main Duties and Responsibilities:

- 1. Cleaning, washing, mopping, sweeping, buffing, vacuum cleaning of all designated areas.
- 2. Emptying rubbish bins.
- 3. Polishing and dusting of the designated areas, (including toilets and shower areas).
- 4. Cleaning windows, fixtures and fittings, using where appropriate powered equipment and cleaning materials according to the agreed procedures.
- 5. Cleaning of bodily fluids as and when required, including the use of specialist chemicals where needed.
- 6. Moving furniture and equipment to assist cleaning.
- 7. Opening and locking doors as required, collecting and returning keys to the Site Service Officer.
- 8. Making sure that work is carried out to the standard required by the Site Services Officer.
- 9. Reporting any hazards, defects and/or any relevant factors of equipment, building or environment safety that may be detrimental to safe working practices, immediately to the Site Service Officer.
- 10. Act in accordance with academy practice that clients are treated courteously.
- 11. Any other duties and responsibilities within the range of the salary grade.
