Job Purpose:

Undertake the cleaning of designated areas within the school, to ensure that they are kept in a clean and hygienic condition. Work will entail regular and one-off cleaning tasks and duties as directed by the Site Services Officer/School/Trust.

Main Duties and Responsibilities:

1. Cleaning, washing, mopping, sweeping, buffing, vacuum cleaning of all designated areas.
2. Emptying rubbish bins.
3. Polishing and dusting of the designated areas, (including toilets and shower areas).
4. Cleaning windows, fixtures and fittings, using where appropriate powered equipment and cleaning materials according to the agreed procedures.
5. Cleaning of bodily fluids as and when required, including the use of specialist chemicals where needed.
6. Moving furniture and equipment to assist cleaning.
7. Opening and locking doors as required, collecting and returning keys to the Site Service Officer.
8. Making sure that work is carried out to the standard required by the Site Services Officer.
9. Reporting any hazards, defects and/or any relevant factors of equipment, building or environment safety that may be detrimental to safe working practices, immediately to the Site Service Officer.
10. Act in accordance with academy practice that clients are treated courteously.
11. Any other duties and responsibilities within the range of the salary grade.

GENERAL

2. Carry out other duties as may reasonably be required from time to time to meet the evolving nature of the Trust.
