JOB TITLE: School Cleaner

RESPONSIBLE TO: Premises Officer

MAIN RESPONSIBILITIES:

The School cleaner will work as part of a team to perform a variety of regular and one-off cleaning tasks and duties as directed by their supervisor/line manager. The School cleaner will provide a high standard of hygiene and cleanliness throughout the school.

- Clean designated areas to a consistently high standard.
- Take initiative to perform cleaning and tidying tasks that are not specifically contained within the daily duties, but require attention as part of maintaining high standards.
- Ensure Health and Safety and general procedure compliance.
- Ensure any issues relating to Health and Safety are reported to the Premises Officer/Business Manager.
- Report cleaning supplies requirements and stock levels to supervisor.
- Undertake any training necessary in the correct use of cleaning equipment such as floor machines, Vacs, wets pick-ups, and in health and safety and the use of cleaning chemicals.
- To work as part of a team and support other members of the cleaning team to meet standards and school objectives.
- To be willing to undertake varied duties according to the needs of the school, as requested.
- Will need to manage some heavy lifting.

The duties in this job description may be varied by the Headteacher/Governing Body at any time, after discussion with you, to meet changing circumstances in a manner compatible with the post held. The job description will be reviewed annually to ensure the tasks are relevant to the needs of the school. It does not form part of your contract of employment. It sets out the way you are expected and required to perform the duties set out above. This is not a complete or definite list of duties, but a guide as to what should be done.
