# **JOB DESCRIPTION**

# Responsibilities

- Develop and quality assure Key Stage 3/4 curriculum, teaching, and assessment material to enable students to enjoy and achieve at the highest possible level.
- Teach and model the delivery of rigorous and engaging lessons that motivate, inspire, and improve pupil outcomes.
- Co-ordinate an effective, flexible, and timely Subject Knowledge Enhancement plan and lead training to develop the skills and expertise of science teachers.
- Disseminate appropriate material and promote the discussion of credible research in education with science staff.
- Coach and mentor science teachers and TCAT science trainees/ ECTs.
- Support local feeder/ TCAT primary schools to ensure an effective transition to Key Stage 3 science.
- Encourage the development of productive and collaborative working relationships across the Trust.
- Promote the school by attending meetings as appropriate such as TCAT meetings and meetings with any partner groups.
- Build effective links with other organisations so that pupils' knowledge and understanding of science is enhanced.
- Under the direction of the Subject Leader support the leadership, management and organisation of science department.

# Principles of Leadership and Management at Beamont Collegiate Academy:

Aspects of **leadership** which would apply to teachers with leadership and management responsibilities include:

- a) Maintaining clear vision, purpose, and high expectations, focused on pupils' achievement;
- b) Maintaining strategic planning for the subject, team, or department co-ordinated with the Academy Development Plan;

- d) Showing a clear commitment to staff development;
- e) Deploying staff effectively and assisting them in managing their workload;
- f) Using financial and resource management effectively to support the achievement of academy aims.

#### **TEACHER STANDARDS**

**PART ONE: TEACHING** 

#### A teacher must:

## 1. Set high expectations which inspire, motivate and challenge students

- establish a safe and stimulating environment for students, rooted in mutual respect
- set goals that stretch and challenge students of all backgrounds, abilities and dispositions
- demonstrate consistently the positive attitudes, values and behaviour which are expected of students.

#### 2. Promote good progress and outcomes by students

- be accountable for students' attainment, progress and outcomes
- analyse students' data and exam performance to inform planning and intervention.
- plan teaching to build on students' capabilities and prior knowledge
- guide students to reflect on the progress they have made and their emerging needs
- demonstrate knowledge and understanding of how students learn and how this impacts on teaching
- encourage students to take a responsible and conscientious attitude to their own work and study.

# 3. Demonstrate good subject and curriculum knowledge

- have a secure knowledge of the relevant subject(s) and curriculum areas, foster and maintain students' interest in the subject, and address misunderstandings
- demonstrate a critical understanding of developments in the subject and curriculum areas, and promote the value of scholarship
- demonstrate an understanding of and take responsibility for promoting high standards of literacy, articulacy and the correct use of standard English, whatever the teacher's specialist subject
- if teaching early reading, demonstrate a clear understanding of systematic synthetic phonics
- if teaching early mathematics, demonstrate a clear understanding of appropriate teaching strategies.

#### 4. Plan and teach well-structured lessons

- impart knowledge and develop understanding through effective use of lesson time
- promote a love of learning and children's intellectual curiosity
- set homework according to the School timetable and plan other out-of-class activities to consolidate and extend the knowledge and understanding students have acquired
- reflect systematically on the effectiveness of lessons and approaches to teaching
- contribute to the design and provision of an engaging curriculum within the relevant subject area(s).

## 5. Adapt teaching to respond to the strengths and needs of all students

- know when and how to differentiate appropriately, using approaches which enable students to be taught effectively
- have a secure understanding of how a range of factors can inhibit students' ability to learn, and how best to overcome these
- demonstrate an awareness of the physical, social, and intellectual development of children, and know how to adapt teaching to support students' education at different stages of development
- have a clear understanding of the needs of all students, including those with special educational needs; those of high ability; those with English as an additional language; those with disabilities; and be able to use and evaluate distinctive teaching approaches to engage and support them.

# 6. Make accurate and productive use of assessment

- know and understand how to assess the relevant subject and curriculum areas, including statutory assessment requirements
- make use of formative and summative assessment to secure students' progress
- use relevant data to monitor progress, set targets, and plan subsequent lessons
- give students regular feedback, both orally and through accurate marking within the agreed time, and encourage students to respond
  to the feedback.
- follow the School's assessments reporting policies.

### 7. Manage behaviour effectively to ensure a good and safe learning environment

- have clear rules and routines for behaviour in classrooms, and take responsibility for promoting good and courteous behaviour both in classrooms and around the School, in accordance with the School's behaviour for learning policy
- have high expectations of behaviour, and establish a framework for discipline with a range of strategies, using praise, sanctions and rewards consistently and fairly
- manage classes effectively, using approaches which are appropriate to students' needs in order to involve and motivate them
- maintain good relationships with students, exercise appropriate authority, and act decisively when necessary.

## 8. Fulfil wider professional responsibilities

- make a positive contribution to the wider life and ethos of the School including extra-curricular
- develop effective professional relationships with colleagues, knowing how and when to draw on advice and specialist support
- deploy support staff effectively
- take responsibility for improving teaching through appropriate professional development, responding to advice and feedback from colleagues
- communicate effectively with parents with regard to students' achievements and well-being.

A teacher is expected to demonstrate consistently high standards of personal and professional conduct. The following statements define the behaviour and attitudes which set the required standard for conduct throughout a teacher's career.
