Situated in the heart of East Ham Plashet is a comprehensive 11 - 16 girls' school of 1,500 students. Our Progress 8 score for 2024 is +0.87 which placed us in the top 4% of schools nationally. In the summer of 2024 our EBacc P8 science score was +0.73 with 65.6% Grade 5 or better, 82.6% Grade 4 or better. Students achieving a standard pass in two sciences was 83% with our science average points score being 5.47. 34% of our cohort were entered for the separate sciences.
