- demonstrate analytical thinking;
- improve the quality of pupils' learning contribute to the school improvement / development planning and promote the learning priorities of the department;
- contribute to the development and / or implementation of school policies;

- use the performance management process to advance pupil learning and enhance professional practice in line with the school's aspirations and priorities;
- have lead responsibility for a subject or aspect of the school's work and develop plans which
 identify clear targets and success criteria for its development and / or maintenance;
- to contribute to the overall ethos, aspirations and strategic aims of the school.

Monitoring, Assessment, Recording, Reporting

- report on progress to all stakeholders.

Pastoral Duties (where appropriate)
