## Main Purpose

The 2nd in Department for Maths holds a key position within the department. The individual will provide high quality leadership based on ambition, high expectations, drive and an uncompromising commitment towards securing improvement. The individual will lead by example.

The individual is responsible for ensuring that the work and ambitions of the Head of Department are realised and will make valuable contributions to shaping and driving both departmental and whole school improvement.

The 2nd in Department for Maths will support, share and drive forward the departmental educational vision and ethos that supports the school's overall improvement priorities. These will be based on rigorous self-evaluation and reflection and will be designed to secure continuous improvement.

The 2nd in Department for Maths will play a key part in the process of Departmental self-evaluation and help to formulate and implement the departmental DIP.

The 2nd in Department for Maths is required to lead on one aspect or area of the department (subject/s or Key Stage) and regularly review and evaluate provision within the specified area as part of the DIP. The individual must provide evidence of priorities identified, actions taken and the impact of these on provision.

Through line management meetings, the 2nd in Department for Maths will provide inspirational leadership to other colleagues within the department to create a positive learning environment based on high expectations, challenge and support.

The individual will work with staff to develop and embed effective learning skills.
