Key Duties	<ul style="list-style-type: none"> • Deputy Subject Leader – Physical Education + another subject • To work collaboratively with the established department to delivery high quality Physical Education across all disciplines, leading as second in faculty. • To lead and contribute to the wider school community in the delivery of extra-curricular opportunities across a range of activities and abilities, particularly rugby, football, basketball, strength and conditioning, cricket, softball and athletics. • To teach, students according to their educational needs, including the setting and marking of work to be carried out by the student in school and elsewhere. • To assess, record and report on the attendance, progress, development and attainment of students and to keep such records as are required. • To provide, or contribute to, oral and written assessments, reports and references relating to individual students and groups of students.

<p>Management of Resources:</p>	<ul style="list-style-type: none"> • To contribute to the process of the ordering and allocation of equipment and materials. • To assist the Head of Faculty to identify resource needs and to contribute to the efficient/effective use of physical resources. • To co-operate with other staff to ensure a sharing and effective usage of resources to the benefit of the School, department and the students.
<p>Pastoral System:</p>	<ul style="list-style-type: none"> • To be a Learning Mentor to an assigned group of students. • To promote the general progress and well-being of individual students and of the Learning Mentor Group as a whole. • To liaise with Learning Leaders to ensure the implementation of the school's Pastoral System. • To register students, accompany them to assemblies, encourage their full attendance at all lessons and their participation in other aspects of school life. • To evaluate and monitor the progress of students and keep up-to-date student records as may be required. • To contribute to the preparation of Action Plans and progress files and other reports. • To alert the appropriate staff to problems experienced by students and to make recommendations as to how these may be resolved. • To communicate as appropriate, with the parents of students and with persons or bodies outside the school concerned with the welfare of individual students, after consultation with the appropriate staff • To contribute to CPSHE and citizenship and enterprise according to school policy • To apply the Behaviour management systems so that effective learning can take place.
