Main purpose of the role

To lead the Secondary Mastery Specialist team to develop high quality mastery teaching and learning throughout the Norfolk and Suffolk region.

Maths Standards Lead

To drive improvements in standards and curriculum, in maths, across all schools in the Trust, as part of a high performing team.
