

## VENTRUS SENDCO JOB DESCRIPTION

**Reports to:** Headteacher and Deputy Headteacher

Accountable to: Headteacher

#### **Main Functions:**

- Act on the Code of Practice for Special Educational Needs & Disabilities (SEND) and ensure all staff are aware of the implications for them.
- Lead high quality SEND provision to ensure excellent outcomes for pupils with SEND.
- Be responsible for the implementation and operation of the SEND Policy.
- Be accountable for the experiences and progress of pupils with SEND.
- Carry out the duties of a teacher as set out in the School Teachers' Pay and Conditions Document and also the Teachers' Standards.

### Main Responsibilities:

- Review effectiveness of and amend SEND Policy annually.
- Establish clear targets for achievement of pupils with SEND.
- Ensure teachers and teaching assistants are able to identify children with SEND and know what should be put in place for these children.
- Ensure children with SEND have SMART targets and that these are reviewed regularly and effectiveness of provision is evaluated.
- Maintain the school's SEND Register.
- Compile and maintain provision maps.
- Provide professional development for staff.
- Report to the SLT about the provision for progress of children with SEND including best value.
- Evaluate the effectiveness of methods used and research new methods of supporting children's learning.
- Be the main SEND contact for parents of children and special educational needs and disabilities.
- Be the main contact for external agencies on all matters of SEND.
- Lead on multi agency meetings/processes, including Early Help, where appropriate.
- Liaise with outside agencies.
- Ensure school practices are compliant with policies, guidance and the Code of Practice.

### **Main Duties:**

- Strategic development of the school's SEND provision and oversight of the day-to-day operation of that policy
- Support and advise teachers and assistants on appropriate provision for children with SEND and evaluate the effectiveness of the provision.
- Ensure the support plans are used effectively to make a difference and are reviewed regularly.



- Demonstrate good inclusion practice within whole class teaching.
- Monitor and appropriateness of the curriculum for children with SEND.
- Regularly monitor work and progress of pupils with SEND.
- Analyse and interpret relevant national, local and school data to inform policies, practice targets and teaching methods.
- Keep inventory of specialist equipment and ensure it is maintained and deployed appropriately.
- Provide training and support for teachers and assistants.
- Establish annual short, medium and long-term plans for the improvement of SEND provision.
