JOB DESCRIPTION

Job Title: SLD / PMLD Lead Teacher

Grade: MPS/UPS + 1 SEN Point +TLR2a

Purpose of Job Role:

- Teach pupils, including those with Severe Learning Disabilities (SLD) and Profound and Multiple Learning Disabilities (PMLD) within our Hospitals and Short-Term Provision.
- Teach to the highest standards of classroom and organisation and to monitor the delivery of curriculum activity within a designated part of the school
- Support and work collaboratively with our SENCO, TDET Colleagues and NHS multidisciplinary professionals.
- Develop knowledge and understanding of specific pupil needs to ensure your teaching is engaging and effective.
- Develop colleagues' pedagogy for teaching pupils with SLD and PMLD.
- Provide regular guidance and support for colleagues' planning for teaching pupils with SLD and PMLD.
- Monitor registers, allocating staff to lessons, ensuring that opportunities for teaching and learning of pupils with SLD and PMLD are maximised.

Duties and Responsibilities:

- Teach designated pupils ensuring that teaching is differentiated to meet the specific needs of pupils.
- Monitor, assess and report progress with regard to individual pupils and class groups, ensuring personalised and effective intervention where appropriate.
- In line with centre and whole school policies to operate appropriate systems of pupil management.
- Assessment, recording and reporting on the development and progress of designated pupils, in particular those with SLD and PMLD.
- Communication and consultation with the clinical staff and parents of pupils assigned for teaching.
- Offer guidance and support to pupils, families and colleagues as appropriate
- Participate in the preparation of pupils for public examinations and end of Key Stage assessment
- Participate in any arrangements for appraisal within the agreed framework
- Ensure that you fulfil your professional safeguarding responsibilities as set out in the school safeguarding policy and relevant government guidance
- Participate in maintaining and developing the aims and objectives of the school.
- Implement a SLD and PMLD curriculum as an entitlement
- Participate in regular Quality Assurance, review and monitoring of curriculum offer and implementation.
- Be a member of the relevant curriculum group attending SEND team meetings / centre meetings
- Monitor and assess progress with regard to individual pupils and class groups, ensuring personalised and effective intervention where appropriate.
- Ensure TDET Teacher Standards are achieved successfully.
- Communicate effectively with home-schools to ensure that education is informed by and consistent with a pupils EHCP.
- Carry out the keyworker role for individual students as required.
