Job Description

This job description outlines duties specific to Southwark Park Primary School which are in addition to those detailed in the duties of a school teacher as set out in the Teachers Pay and Conditions.

Main Purpose

The SENDCo, under the direction of the headteacher, will:

- Ensure the needs of all children with Special Educational Needs and Disabilities (SEND) are met in accordance with the SEND Code of Practice.
- Determine the strategic development of Special Educational Needs and Disabilities policy and provision in Southwark Park Primary School.
- Be responsible for the day to day operation of the SEND policy and co-ordination of specific provision to support individual pupils with SEND or medical need.
- Provide professional guidance to colleagues, working closely with staff, parents and other agencies.

The SENDCo will also be expected to fulfil the professional responsibilities of a teacher, as set out in the School Teachers' Pay and Conditions Document and Teacher Standards.

Duties and Responsibilities

Strategic development of SEND policy and provision

- Have a strategic overview of provision for pupils with SEND across the school, monitoring and reviewing the quality of provision.
- Contribute to school self-evaluations, particularly with respect to provision for pupils with SEND
- Ensure the SEND policy is put into practice, and that the objectives of this policy are reflected in School Improvement Plans
- Maintain an up-to-date knowledge of national and local initiatives which may affect the schools' policies and practices
- · Evaluate whether funding is being used effectively, and propose changes to make use of funding more effective
- Collaborate and share good practice with SEND colleagues across the Borough

Operation of the SEND policy and co-ordination of provision

- Maintain accurate SEND registers and provision maps
- Provide guidance to colleagues on teaching pupils with SEND and advise on the graduated approach to SEND support
- Advise on the schools' budgets and other resources to meet pupils' needs effectively, including staff deployment
- Be aware of the provision in the relevant local offer
- Work with early years providers, other schools, educational psychologists, health and social care professionals, and other external agencies
- Be a key point of contact for external agencies, especially the local authorities
- Analyse assessment data for pupils with SEND
- Implement and lead intervention groups for pupils with SEND, and evaluate their effectiveness

Support for pupils with SEND

- Identify a pupil's SEND
- Coordinate provision that meets the pupil's needs, and monitor its effectiveness
- Secure relevant services for the pupil
- Ensure records are maintained and kept up to date
- Review the education, health and care plan with parents or carers and the pupil
- Communicate regularly with parents or carers
- Ensure that if the pupil transfers to another school, all relevant information is conveyed to it, and support a smooth transition for the pupil
- Promote the pupil's inclusion in the school community and access to the curriculum, facilities and extracurricular activities
- Work with the designated teacher for looked-after children, where a looked-after pupil has SEND

Leadership and Management

- Work with the school leadership team (SLT) and governors to ensure the school meets its responsibilities under the Equality Act 2010 in terms of reasonable adjustments and access arrangements
- Attend weekly SLT meetings and carry out actions as required
- Ensure the school's provision for SEND is regularly reviewed and evaluated, and that the outcomes for children with SEND are monitored and reported to the headteacher, governors, and external agencies as required
- Prepare and review information the governing bodies are required to publish
- Contribute to the school improvement plans and whole-school policies
- Identify training needs for staff and how to meet these needs
- · Lead INSET for staff
- Share procedural information, such as the schools' SEND policies
- Promote an ethos and culture that supports the schools' SEND policies and promotes good outcomes for pupils with SEND
- Lead and manage teaching assistants working with pupils with SEND
- Lead staff appraisals and produce appraisal reports
- Review staff performance on an ongoing basis
