Job Purpose

- Help organise and deliver a comprehensive calendar of high-quality competitions and events, in a range of sports and activities at different levels, ensuring all pupils (Y1-Y6) have a chance to compete.
- Support the NPCAT Sport Vision and Mission of providing world class Physical Education, School Sport and Physical Activity (PESSPA) that caters for all and positively impacts upon the lives of our pupils, equipping them with the skills and attitudes that will open up a world of enjoyment, experience and achievement.
- Provide a range of opportunities and offer bespoke training and support to ensure all schools offer incentives for personal development and recognise and reward pupils' leadership skills.
- Work with schools to support their understanding of the identification and development of skilled pupils offering expert coaching to these 'Sporting Stars' to increase their chances of success.

## Main Duties & Responsibilities

- Deliver a comprehensive calendar of high-quality trust wide competitions and events, in a range of sports and activities and at different levels, that complements the curriculum and promotes Catholic values.
- Ensure all schools are accessing appropriate opportunities for all children to compete in both performance and participation events.
- Provide additional in school support to ensure all children are fully prepared, especially for performance level events with the requisite knowledge of rules, strategies and tactics.
- Help develop the engagement in school sport and physical activity to ensure children are more physically literate in every school, including those in under-represented groups such as girls, SEND, EAL and Pupil Premium, who will subsequently go on to lead more active, healthy lifestyles.
- Deliver extracurricular clubs designed to profile sport and motivate all children and young people to get involved.

- Support schools to recruit and develop young leaders and provide training for these pupils to lead sport and physical activity initiatives to further increase participation.
- Ensure schools are fully engaged in the NPCAT Sport Leadership Passport and developing young leaders who excel in skills such as organisation, communication, decision making and teamwork and who can take these attributes into their school and local communities.
- Encourage the schools to find more ways to help all children and young people to accumulate an average of at least 30 minutes of physical activity per day in school across the week.
- Provide a specialised programme of coaching to enable skilled pupils to acquire the necessary skills and knowledge to compete at a high level.
- Signpost identified 'Sporting Stars' to local clubs who can nurture and develop their individual talents further.
