Job Description

1. Principal Responsibilities

The class teacher will undertake all duties of a qualified teacher identified in the Teachers' Pay and Conditions Document and will undertake teaching of a year 5 and 6 class.

2. Teaching and Learning

Demonstrate highly effective teaching by:

- Setting high expectations which inspire, motivate and challenge
- Ensuring good progress and outcome by pupils
- Demonstrating good subject and curriculum knowledge
- Evidence of exceptional progress made by individuals or groups
- Planning and teaching well structured, exciting and stimulating lessons
- Adapting teaching to respond to the strengths and needs of all pupils
- Making accurate and productive use of assessment
- Managing behaviour effectively
- Having experience of working with children with a range of special educational needs and be able to provide positive and targeted support
- Having an awareness of the challenge needed for able and talented children
- Showing awareness of national trends in pedagogy and practice
- Commitment to personal welfare and safeguarding of children
- Evidence of exceptional practice recognised by external and internal sources
- Be a reflective practitioner who embraces the opportunity for learning and selfdevelopment

3. Monitoring, Assessment, Recording, Reporting

- Assess how well learning objectives have been achieved and use them to improve specific aspects of teaching
- Mark and monitors pupils work and set targets for progress; Assess and records pupils
 progress systematically and keep records to check work is understood and completed,
 monitor strengths and weaknesses, inform planning and recognise the level at which the
 pupil is achieving
- Prepare and present informative reports to parents and governors
- Understand the procedures and arrangements for administering the end of Key Stage 2 SATs assessments.

4. Other Professional Requirements

- Have a working knowledge of teachers' professional duties and legal liabilities; Operate at all times within the stated policies and practices of the school
- Establish working relationships and set a good example through the professional conduct;
- Endeavour to give each child the opportunity to reach their potential and meet high expectations;
