<b>Job title</b>	Teacher of Art, Secondary Phase (to cover maternity leave)
<b>Reporting to</b>	Head of Art, Deputy Headteacher responsible for Quality of Education
<b>Main purpose of job</b>	The post holder will be expected to teach Art across the full age and ability range.
<b>Main Tasks:</b>	
<ul style="list-style-type: none"><li>• To plan their teaching to achieve progression in pupils' learning</li><li>• To set high expectations for pupils' behaviour, establishing and maintaining a good standard of discipline through well focused teaching and through the development of positive and productive relationships</li><li>• To use a variety of teaching methods, including ICT, which sustain the momentum of pupils' work and keep all pupils engaged</li><li>• To make effective use of assessment information to inform planning and maximise learner progress</li><li>• To mark and monitor pupils' classwork and homework (keeping accurate records), providing constructive oral and written feedback and setting appropriate targets to maximise pupils' progress</li><li>• To develop, evaluate and update schemes of work across all Key Stages</li><li>• To be familiar with the statutory assessment and reporting requirements and know how to prepare and present information reports to parents</li><li>• To be familiar with the Code of Practice on the identification and assessment of Special Educational Needs and as part of their responsibilities implement and keep records of Individual Education Plans for pupils when required</li><li>• To evaluate their own teaching critically and to use this to improve their effectiveness</li><li>• To attend and contribute fully to meetings and progress evenings as required</li><li>• To contribute to activities identified in the Faculty Improvement Plan</li><li>• To carry out the role and responsibilities of a form tutor</li><li>• To contribute to the planning and delivery of wider curricular activities</li></ul>
