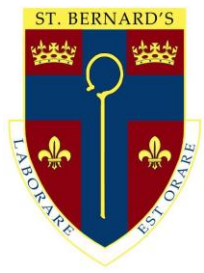

- A variety of teaching strategies and resources, including e-learning, which meet learners' needs and take practical account of diversity and promote equality and inclusion.



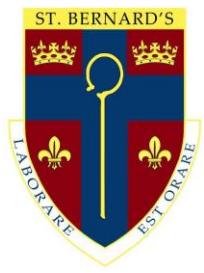

- 3.1 Plan, set and assess homework, other out-of-class assignments and coursework for examinations following the school timetable.



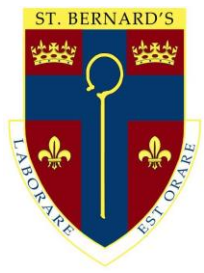

- Contributing (and leading where appropriate) to CPD activities within the department and the wider school (*UPS 1 and above*)

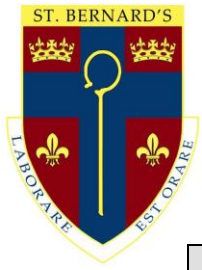
