- 3. Build team commitment with colleagues and in the classroom engage and motivate pupils;
- Demonstrate analytical thinking Improve the quality of pupils' learning contribute to the school improvement / development planning and promote the learning priorities of the School Development Plan;
- 5. Contribute to the development and / or implementation of school policies;
- 6. Use the performance management process to advance pupil learning and enhance professional practice in line with the school's aspirations and priorities;
- 7. Have responsibility for a subject or aspect of the school's work and develop plans which identify clear targets and success criteria for its development and / or maintenance in relation to the wider School Development Plan
- 8. Promote the wider aspirations and values of the school.

# Planning, Teaching and Class Management

Teach allocated pupils by planning their teaching to achieve progression of learning through:

- 1. understanding and applying effective classroom management;
- 2. understanding and applying a range of teaching strategies, including effective use of :
  - formative an summative assesment
  - use of pupil progress and attainment data
  - effective marking
- 3. positively targeting and supporting individual learning needs;
- 4. maintaining high levels of behaviour and discipline;
- 5. effectively using homework and other extra-curricular learning opportunities;
- 6. demonstrating appropriate consistent progress
  - for the majority of pupils
  - across all teaching areas
  - across all spectrums of background, ability and behaviour
  - that compares favourably with pupils in similar settings
- 7. effectively managing other adults in the classroom.

# Monitoring, Assessment, Recording, Reporting

- 1. use performance data to evaluate pupils' progress and set appropriate targets for improvement;
- 2. use assessment to inform planning and teaching;
- 3. report on progress to line management and families as required.

# Pastoral Duties (where appropriate)

- 1. be a form tutor to an assigned group of students;
- promote the general progress and well-being of individual students and of the Form Tutor Group as a whole;
- 3. liaise with the Pastoral Leader to ensure the implementation of the school's pastoral system;
- 4. register students, accompany them to assemblies, encourage their full attendance at all lessons and their participation in other aspects of school life;
- 5. contribute to the preparation of Action Plans and progress files and other reports;
- alert appropriate staff to problems experienced by students and make recommendations as to how these may be resolved;
- communicate, as appropriate, with parents of students and persons or bodies outside the school concerned with the welfare of individual students, after consultation with appropriate staff;
- 8. contribute to PHSE and citizenship and enterprise according to school policy;

- 9. plan, organise and run an after school club related to your subject expertise;
- 10. contribute to lunchtime / break time cover.

- 1. have a working knowledge of teachers' professional duties and legal liabilities;
- 2. operate at all times within the stated policies and practices of the school;
- 3. maintain an up to date knowledge of good practice in teaching techniques;

  - share outcomes with colleagues
- 10. take responsibility for professional learning.
