A Person Specification defines the required professional qualifications, knowledge, skills, and qualities of the teachers sought by the Minster School Governors in the recruitment and selection process.

Newly qualified teachers may only meet the essential requirements and have limited experience of the desirable features gained from school experience but are encouraged to apply for the post.

All members of staff employed by the Minster School support and promote the school's aims:

- 2. To engender a lifelong love of learning
- 3. To encourage each child to strive for his or her best in intellectual, physical, and spiritual growth

- 5. To encourage and develop leadership and active citizenship within the school and wider community which fosters a sense of dignity, vocation and purpose for every individual
- 6. To develop and maintain excellence in teaching and learning
