#### BASIC JOB PURPOSE

- To implement and deliver an appropriately broad, balanced, relevant and differentiated curriculum for students and to support a designated curriculum area as appropriate.
- To monitor and support the overall progress and development of students as a teacher/form tutor.
- To facilitate and encourage a learning experience which provides students with the opportunity to achieve their individual potential.
- To contribute to raising standards of student attainment.
- To share and support the academy's responsibility to provide and monitor opportunities for personal and academic growth.

#### MAIN RESPONSIBILITIES

	<i>Teaching</i>
<b>1</b>	To teach students according to their educational needs, including the setting and marking of work to be carried out by the student in the academy and elsewhere.
<b>2</b>	To assess, record and report on the attendance, progress, development and attainment of students and to keep such records as are required.
<b>3</b>	To provide, or contribute to, oral and written assessments, reports and references relating to individual students and groups of students.
<b>4</b>	To ensure that ICT, Literacy, Numeracy and academy subject specialism(s) are reflected in the teaching/learning experience of students.
<b>5</b>	To undertake a designated programme of teaching.
<b>6</b>	To ensure a high quality learning experience for students which meets internal and external quality standards.
<b>7</b>	To prepare and update subject materials.
<b>8</b>	To use a variety of delivery methods which will stimulate learning appropriate to student needs and demands of the syllabus.
<b>9</b>	To maintain discipline in accordance with the academy's procedures and to encourage good practice with regard to punctuality, behaviour, standards of work and homework.
<b>10</b>	To undertake assessment of students as requested by external examination bodies, the subject area and academy procedures.
<b>11</b>	To mark, grade and give written/verbal and diagnostic feedback as required.

	<i>Pastoral System</i>
<b>1</b>	To be a form tutor to an assigned group of students.
<b>2</b>	To promote the general progress and well-being of individual students and of the form tutor group as a whole.

<b>3</b>	To liaise with the Head of Year to ensure the implementation of the academy's Pastoral System.
<b>4</b>	To register students, accompany them to assemblies, encourage their full attendance at all lessons and their participation in other aspects of academy life.
<b>5</b>	To evaluate and monitor the progress of students and keep up-to-date student records as may be required.
<b>6</b>	To contribute to the preparation of Action Plans and progress files and other reports.
<b>7</b>	To alert the appropriate staff to problems experienced by students and to make recommendations as to how these may be resolved.
<b>8</b>	To communicate as appropriate, with the parents of students and with persons or bodies outside the academy concerned with the welfare of individual students, after consultation with the appropriate staff.
<b>9</b>	To contribute to PSHE and Citizenship and enterprise according to academy policy.
<b>10</b>	To apply the Behaviour Management systems so that effective learning can take place.

	<i>Operational/Strategic Planning</i>
<b>1</b>	To assist in the development of appropriate syllabuses, resources, schemes of work, marking policies and teaching strategies in the subject area.
<b>2</b>	To contribute to the subject area's Development Plan and its implementation.
<b>3</b>	To attend all appropriate meetings.
<b>4</b>	To plan and prepare courses and lessons.
<b>5</b>	To contribute to the whole academy's planning activities.
<b>6</b>	To assist the Head of Faculty to ensure that the curriculum area provides a range of teaching which complements the academy's Strategic Objectives.

	<i>Staff Development: Recruitment/Deployment of Staff</i>
<b>1</b>	To take part in the academy's staff development programme by participating in arrangements for further training and professional development.
<b>2</b>	To continue personal development in the relevant areas including subject knowledge and teaching methods.
<b>3</b>	To engage actively in the Performance Management Review process.
<b>4</b>	To ensure the effective/efficient deployment of classroom support.
<b>5</b>	To work as a member of a designated team and to contribute positively to effective working relations within the academy.

	<i>Quality Assurance</i>
<b>1</b>	To contribute to the process of monitoring and evaluation of the subject area in line with agreed academy procedures, including evaluation against quality standards and performance criteria.
<b>2</b>	To seek/implement modification and improvement where required.
<b>3</b>	To review from time to time methods of teaching and programmes of work.
<b>4</b>	To take part, as may be required, in the review, development and management of activities relating to the curriculum, organisation and pastoral functions of the academy.

	<i>Management of Information</i>
<b>1</b>	To maintain appropriate records and to provide relevant accurate and up-to-date information for Management Information Systems (MIS), registers etc.
<b>2</b>	To complete the relevant documentation to assist in the tracking of students.
<b>3</b>	To track student progress and use information to inform teaching and learning.
<b>4</b>	To maintain appropriate records and to provide relevant accurate and up-to-date information for Management Information Systems (MIS), registers etc.

	<i>Communications</i>
<b>1</b>	To communicate effectively with the parents of students as appropriate.
<b>2</b>	Where appropriate, to communicate and co-operate with persons or bodies outside the academy.
<b>3</b>	To follow agreed policies for communications in the academy.

	<i>Management of Resources</i>
<b>1</b>	To contribute to the process of the ordering and allocation of equipment and materials.
<b>2</b>	To assist the Head of Faculty to identify resource needs and to contribute to the efficient/effective use of physical resources.
<b>3</b>	To co-operate with other staff to ensure a sharing and effective usage of resources to the benefit of the academy, subject area and the students.

	<i>Other Specific Duties</i>
<b>1</b>	To continue personal development as agreed at appraisal.
<b>2</b>	To engage actively in the performance review process.
<b>3</b>	To address the appraisal targets set by the line manager each Autumn Term.
<b>4</b>	To undertake any other duty as specified by School Teachers' Pay and Conditions Body (STPCB) not mentioned in the above.
<b>5</b>	To play a full part in the life of the academy community, to support its distinctive aim and ethos and to encourage staff and students to follow this example.
<b>6</b>	To promote actively the academy's corporate policies.
<b>7</b>	To comply with the academy's Health and Safety policy and undertake risk assessments as appropriate.
<b>8</b>	To adhere to the academy's Dress Code.
