JOB DESCRIPTION

Role:

You will have a passion for the subject, an enthusiasm for teaching, and a commitment to supporting the academic and holistic development of every student within their care.

You will:

- plan and deliver an innovative, engaging and ambitious Maths curriculum which provides students with the requisite knowledge, skills, and cultural capital
- teach high quality, personalised and inclusive lessons to classes across Key Stages 3 and 4 to secure strong progress and outcomes for all learners
- uphold high expectations of all learners with a commitment to ensuring that they can achieve their full educational potential through establishing fair, respectful, trusting supportive and constructive relationships
- have a commitment to collaboration, co-operative working and continued professional development
- share and drive the academy vision of 'Everyone Exceptional'

Teaching, Learning & Pedagogy:

- Ensure a high-quality learning experience for all students through effective personalisation; appropriately sequencing and scaffolding learning to ensure all students are able to engage successfully with the curriculum.
- Foster a love for the subject, enhancing reasoning and problem-solving skills.
- Use assessment as part of teaching to diagnose learners' needs, set realistic and challenging targets for improvement and plan future teaching.
- Use data to evaluate the effectiveness of teaching, to monitor the progress of those taught, and to raise levels of attainment.
- Assess, record and report on the progress, development, and attainment of students
- Manage learners' behaviour constructively by establishing and maintaining a clear and positive framework for behaviour management, in line with the academy's Behaviour Policy.
- Promote learners' self-regulation, resilience, and collaboration through developing their social, emotional, and behavioural skills.
- Have a secure knowledge and understanding of the Maths curriculum and related pedagogy, including the contribution that Maths can make to crosscurricular learning, and recent relevant developments.

Staff Development:

- Actively participate in the academy's professional development programme.
- Continually enhance personal and professional development including subject knowledge and teaching methods.
- Participate in full staff and department meetings, actively contributing to academy decision making, consultation procedures and feedback opportunities.
- Engage actively in the performance management review process to enhance personal performance, fulfil personal potential and contribute effectively to the implementation of the academy's goal to be exceptional.
- Ensure the effective/efficient deployment of classroom support.
- Work as a member of a designated team and to contribute positively to effective working relations within the academy.

Communications:

- Communicate effectively with the parents of students as appropriate.
- Take part in academy activities including open evenings, parents' evenings, and trust events.
- Contribute to the development of effective subject links with schools across the trust and external agencies.

Care, Guidance and Support:

- Be a guardian (Form Tutor) to an assigned group of students, actively contributing to guardian time and other tutor-based curriculum activities.
- Promote both the academic and holistic progress and wellbeing of individual students and of the guardian group, being their key advocate.
- Register students, accompany them to assemblies, encourage their full attendance at all lessons and their participation in other aspects of school life.
- Evaluate and monitor the progress of students and keep up-to-date student records.
- Know when to draw on the expertise of colleagues, such as those with responsibility for the safeguarding of children and young people and special educational needs and disabilities, and to refer to sources of information, advice, and support from external agencies.
