## Dear Colleague

Thank you very much for your interest in the position of Teacher of MFL at Aldworth School. We are a school which is proud to serve the area and works hard to foster a sense of belonging amongst all members of our diverse community. You would be joining us at a very exciting time for the school and I would really encourage you to explore our website to learn a little more about our journey.

The school is currently in a period of transition under my leadership as the new Headteacher, and we are on a positive trajectory with the aim of reaching a solid good in our next full Ofsted inspection. Aldworth has been transformed over the last couple of years and outcomes are now stronger and continuing to improve.

I feel privileged to work with a team focused on delivering the best for our community and we are excited about the next stage of our journey. Despite an RI judgement from Ofsted in June 2019, staff morale is high and there is a determination to drive continual improvements to the school. With support from the LA and a focus on continual professional development, there will be a range of opportunities arising over the next year for committed and ambitious staff. Our most recent Ofsted visit confirmed that we are taking effective action in order for the school to become a good school, and the report unusually contained no action points. It noted our rapid pace of improvement, and this has been backed up by a visit from the LA which has also confirmed our development work is well-established and we are well placed to continue our upward trend of improvement.

The MFL department is well-regarded within the school, and at the forefront of developing and embedding our teaching and learning strategy. Students study either French, German or Spanish at KS3 and are able to opt for all 3 languages at KS4. We are looking for someone who is able to offer at least two of these languages, and will consider a part time or full time appointment.

We welcome applications from a range of staff from more experienced teachers to those newer to the profession; we can somewhat shape the position for the correct person and will look positively on all applicants. The school actively encourages applicants from a range of backgrounds and is proud of the diversity of the staff.

We take the safety of our students very seriously and as such appointments will be subject to full safeguarding checks, including an enhanced DBS check. The school reserves the right to close the position early on receipt of a strong application, so if you are interested we would urge you to apply sooner rather than later.


