The interview process will be organised to provide a range of assessment tasks and opportunities for candidates to find out more about the school and demonstrate their ability to fulfil the role.



MAIN RESPONSIBILITIES OF THE ROLE

- To ensure high standards of teaching and learning within the department.
- To ensure the department is contributing to raising standards of progress and attainment at Key Stage 5.
- To fully engage with the departments extra-curricular provision.
- To conduct a full analysis of relevant data sources available throughout the academic year.
- To ensure teaching meets the needs and aspirations of all students.
- To ensure there is a programme of Continuing Professional Development for all colleagues and to contribute personally to this programme.
