# Department information

## Science

### Curriculum

---

#### Key Stage 3

- Utilising a Clarendon produced scheme of learning students focus on 10 key concepts in science to establish a broad but detailed foundation of knowledge; this is built on cumulatively and revisited across Years 7-9.
- The department aims for KS3 classes to be taught by a single member of staff across their 6 hours of science lessons per fortnight.
- Pupils are taught in sets determined by KS2 and CATs data; movement between sets is facilitated where appropriate and warranted.

#### Key Stage 4

- The department have developed their own GCSE curriculum scheme to deliver the AQA Science specifications.
- GCSE level teaching begins in Year 10 and all students study at least a Combined Science course (delivered across 10 hours per fortnight by three specialist teachers, one per discipline).
- Based on their KS3 outcomes, students are invited to choose an option of Separate Sciences; if selected these students have an additional 5 hours per fortnight.

#### Key Stage 5

- Clarendon offers four post-16 courses: AQA A-Level Biology, OCR A-Level Chemistry, AQA A-Level Physics and AQA Extended Certificate in Applied Science.

### Department accommodation and resources

---

The Science faculty are housed together in one block and comprises 8 laboratories, 1 shared computer room and a dedicated science staff room. All full-time teachers have their own room in which they teach and access to a wide variety of resources and practical equipment.

#### Extra-curricular activities

---

Extra-curricular offerings are mainly focused on supporting students completing their GCSE and A-Level studies, with staff providing a timetable of subject-specific support sessions and lecture style opportunities to support, stretch and challenge.

#### Department structure

---

As one of the larger faculties in the school, the Science department currently has ten members of staff, supported by three technicians. Staff have multiple specialisms and work collaboratively to share and improve best practice. The department aims to instil a lifelong interest in Science and provide them with skills that they can use, no matter what their future profession is. It is a supportive and friendly faculty, where new ideas and approaches are welcome and openly discussed.

# Department information

## *Physical Education (PE)*

### Curriculum

---

All pupils have a minimum access to four hours of subject time per fortnight.

#### Key Stage 3

- Students are exposed to a broad range of sports and activities.
- Assessment focus is based on core sporting principles of social interaction, self-drive, participation, coachability and mental strength.
- All pupils are assessed on skills throughout their time at Clarendon to ensure that they all engage and acquire a range of invaluable skills.

#### Key Stage 4

- In KS4 pupils skills are further honed;. In addition to exposure to the same breadth of sports and activities from KS3 (core PE lessons), pupils also have access to 'Games' lessons which are centred around the Sports Education model.
- This entails full match inclusion of participants in order to benefit from improved game understanding, as well as the recognised health benefits attributed to regular participation in sport and exercise.

#### Examination

- Pupils are given the opportunity to take Sport as a qualification from Year 10 onwards.
- A range of vocational courses are available including Cambridge Nationals Level 2 and Sport Leaders.
- Our outstanding attainment outcomes for Level 2 (Years 10-11) make us one of the strongest delivers in the region and allows students to achieve grades far above the national average.

### Department accommodation and resources

---

The PE faculty is housed together in one block; it comprises two classrooms and one computer room (for examination courses). The faculty also benefits from a large gym, multi-use sports hall (with viewing balcony), swimming pool and two squash courts. Outside there are extensive fields, a red-gra and fitness suite.

### Extra-curricular activities

---

The department boasts an extensive and successful extra-curricular programme which runs over three terms, in addition to regular enrichment activities. There is also a bi-annual international sports tour.

### Department structure

---

The experienced and dynamic team of nine teachers and three assistants (who work specifically with children with additional needs) are fully focused on the achievement and wellbeing of the students in their care.

- Participate in arrangements for preparing pupils for external tests

### Whole-school organisation, strategy and development

- Contribute to the development, implementation and evaluation of the school's policies, practices and procedures, so as to support the school's vision and values
- Make a positive contribution to the wider life and ethos of the school
- Work with others on curriculum and pupil development to secure co-ordinated outcomes
- Provide cover, in the unforeseen circumstance that another teacher is unable to teach
