<p><b><u>Overall Purpose of Job:</u></b></p> <p>In the role of Teacher of Music &amp; Performing Arts you will:</p> <ul style="list-style-type: none"> <li>• carry out the professional duties of a teacher as circumstances may require and in accordance with academy policies, under the direction of the Principal</li> <li>• promote the achievement of high standards through effecting teaching and learning of Music &amp; Performing Arts, including preparation, evaluation, and action planning</li> <li>• model the vision and values of the academy</li> <li>• be part of the team driving the development of the academy to become and remain an ‘outstanding’ academy</li> <li>• receive and act on feedback to build on the strengths and improve personal performance within the academy systems</li> <li>• contribute, where appropriate, to implementing policies and practice and to promote collective responsibility for their implementation</li> <li>• take into account and constantly reviewing academy contextual factors and prior attainment when planning and teaching lessons</li> <li>• work in a cross-curricular way to support Music &amp; Performing Arts across the academy in the use of active learning approaches to enrich curriculum and skills delivery</li> <li>• recognise, promote, and celebrate diversity</li> </ul>

Being accountable for student progression for allocated classes.</li> <li>4. Being responsible for effective classroom management.</li> <li>5. Co-ordinating class work with any classroom assistant support.</li> <li>6. Developing and sustaining knowledge of current educational practices and be responsible for own continuing professional development.</li> <li>7. Evaluating lessons, incorporating students’ views and responses in order to reflect and act on strengths and areas for development.</li> <li>8. 25. Co-ordinating displays with regards to events, opportunities and work which promote the department/academy.

**Develop and sustain DEEP SUPPORT across the academy through:**

26. Taking responsibility for upholding standards of behaviour and classroom management within the classroom and the schools environment.
27. Promoting the consistent and fair use of the behaviour policy within the classroom and the academy environment.
28. Being the first line of contact for parents and carers concerns with regards to their child's performance and well-being of your classes.
29. Performing the duties of a Vertical Mentor Tutor if required, including the provision of information, advice, and guidance for students.
