The post offers an exciting opportunity to teach and make a positive difference in our outstanding school, a converter Academy and the founding school of Moorlands Learning Trust (MLT). We very much welcome your interest and hope the accompanying information will encourage you to apply. The role is to cover maternity leave and is anticipated that this will be required from September 2021 for a full academic year.

The successful candidate will join a very popular and ambitious curriculum area where standards and levels of student engagement are high. They will have high expectations, expert subject knowledge, a strong and positive work ethic and an unwavering commitment to all students achieving their full potential in psychology through consistently excellent teaching. Working collaboratively as part of a dedicated and talented team, they will be inspirational to both students and colleagues, and will be committed to sharing best practice, pedagogy and contributing to enrichment, intervention and the development of the department.

This is an exciting time in the school's development. Following a £4.7 million capital investment from Bradford Metropolitan District Council (BMDC), our learning environment has been enhanced by an additional three-storey teaching block for with 15 new classrooms (all equipped with interactive screens), a dining hall and indoor flexible space. In addition, we have also opened a 12 place Specialist Resource Provision (SRP) for students with autism as part of our commitment to inclusive education. Indeed, whilst we have a long history dating back to 1607, we are a modern school with innovation at the heart of our vision as a learning community. We continually advance our curriculum to be responsive to student need and have rolled out iPads to all students to personalise learning and prepare them for life and work in the 21st Century. We also invest in the professional development of our staff to keep ourselves at the cutting edge of educational development.

We are very proud of our excellent reputation in the local community, as well as the wider Leeds and Bradford areas and pride ourselves on the quality of education we provide to our students. Our Ofsted inspection of March 2017 confirmed us as an 'Outstanding' school in all areas, where students "attain highly and make excellent progress", where behaviour is "exemplary" and where "teachers go the extra mile to make sure students achieve, feel cared for and thrive within a supportive and productive learning environment" (Ofsted March 2017). Our success was also recognised in The Sunday Times Schools Guide 2018 with Ilkley Grammar School named as the top ranked comprehensive school in the north of England.

Since achieving our 'Outstanding' Ofsted rating, the school has gone from strength to strength. Our 2020 A-level and GCSE results were outstanding: 44% of all A-level entries were at A/A* and 70% at A*-B; at GCSE over 43% of all GCSE entries were achieved at 7+ this year - a 2% rise on last year's IGS results and over 15% above this year's national rate, with a very impressive 27% of all entries achieved at the very top level of grades 9/8 - almost double the national rate and in line with IGS's performance in previous years. As a result, progress of all students is well above average with a score of +.58 in 2019 and, although performance tables will not be published this year, our P8 score based on the 2019 formula is +.74. This is in line with the upward trajectory of improvement we have maintained over a number of years.

As a comprehensive academy, our overriding aim at IGS is to ensure that our students achieve everything that they are capable of – their 'Personal Best' - from Year 7 through to Sixth Form and beyond. We recognise every student as an individual, with different needs and talents, and we work hard together to make sure we support and nurture successful, happy and confident learners who achieve in the widest sense of the word, and not just academically.

Staff wellbeing is also extremely important to the school and we have recently introduced a number of extra-curricular, voluntary 'Wellbeing Wednesday' sessions for staff to access across the school year. The school closes earlier for students on Wednesdays in order to accommodate these sessions as well as to facilitate whole school and departmental staff CPD.

Despite our considerable success, we are not complacent and our commitment to Personal Best means that we continue to drive school improvement in order to further raise standards. We can guarantee high-quality support in the role, committed and effective colleagues, well-motivated and aspirational students, opportunities for partnership working and a very supportive community. In return, we will expect a positive and enthusiastic approach, someone with emotional intelligence, an unwavering commitment to Personal Best and a passion for working with young people to make a positive difference to their lives.

Departmental Subject Profile: Psychology/ Sociology and Criminology

Department Ethos

Currently Psychology and Sociology are taught at AS and A level only. Since September 2020, Criminology is also offered as a level 3 Diploma (WJEC). The department is a highly successful area in our outstanding and growing sixth form.

Our aim in the Psychology and Sociology department is to provide sixth form students with an engaging and exciting learning experience that encourages independence and prepares students for the next step, be it Higher Education or Work. We aim to teach students the skills to be able to investigate and question the causes of human behaviour in an evaluative way. As well as learning a new subject, students also develop skills such as independence, collaboration and self-reflection to prepare them for life beyond post-16.

The Team and teaching Structure

The department currently consists of 4 teachers: The Head of Department, 2 Teachers of Sociology and Criminology and a Teacher of Psychology who would normally teach a small amount of Sociology. Staff are passionate about their subject and work collaboratively in their planning to ensure students have a consistent experience throughout the department. Lessons are innovative and focus on the application and evaluation of subject knowledge using a variety of tasks, learning strategies and resources.

Results

The department prides itself in gaining high value added results which are consistently above the national average.

The Curriculum

A level Sociology (AQA)

Sociology is a popular A level subject currently with 70 students studying the subject at A level. We teach the AQA Sociology specification and currently students choose to sit the AS level at the end of year 12 or the full A level at the end of year 13. Although the number of groups vary from year to year, there are typically 3 year 12 groups (11 lessons per 2 week cycle each) and 2 year 13 groups (11 lessons per cycle each). All groups are mixed ability with target grades ranging from grades A* to D.

A level Psychology (AQA)

In Psychology we also teach the new AQA Psychology specification and students choose to sit the AS after one year or the full A level after 2 years. Psychology is one of the most popular A level subjects in the school with over 100 students currently studying the subject at Post 16. There are currently 3 year 12 groups and 4 year 13 groups. All groups are mixed ability with target grades ranging from grades A* to D.

Level 3 Diploma in Criminology

There are currently 43 students studying for the Level 3 Criminology Diploma WJEC in year 12 with all students studying the Diploma course for the full 2 years. There are currently 3 year 12 groups taught by 3 teachers. All groups are mixed ability with target grades ranging from grades A* to D.

Departmental Resources

The department is based in the Bronte building with 3 refurbished teaching rooms. Schemes of work and teaching resources for all the A level teaching topics are held centrally allowing staff to access shared resources. Students have access to a digital textbook in Psychology and there is a class set of text books for each classroom in Psychology and Sociology. Copies of the textbooks are also available in the library with students encouraged to buy their own.

General

The department has an excellent reputation and many students achieving outstanding results and moving on to Russell Group and other universities. The post would ideally suit an individual who is committed to continuing the development of initiatives which support the ability range of learners.
