Main purpose of the job:

- Be ambitious for our young people and for themselves
- Be responsible and accountable for achieving the highest possible standards in work and conduct
- Treat students with dignity, building relationships rooted in mutual respect, and at all times observing proper boundaries appropriate to a teacher's professional position
- Work proactively and effectively in collaboration and partnership with learners, parents/carers, trustees, other staff and external agencies in the best interests of students
- Act within the statutory frameworks which set out their professional duties and responsibilities and in line with the duties outlined in the current School Teachers Pay and Conditions Document and Teacher Standards (2012)
- Take responsibility for promoting and safeguarding the welfare of children and young people within the school and Trust
- This role will be based at Falmouth School but you may be required to work at any other premises occupied by the Trust or any of the employer's academies within mid-Cornwall as directed by the employer

Duties and responsibilities:

All teachers are required to carry out the duties of a school teacher as set out in the current *School Teachers Pay and Conditions Document*. Teachers should also have due regard to the Teacher Standards (2012). Teachers' performance will be assessed against the teacher standards as part of the appraisal process as relevant to their role in the school/Trust.

Teaching

- Deliver the curriculum as relevant to the age and ability group/subject/s that you teach
- Planning and preparing lessons that meet the requirements of the school
- Teaching assigned students according to their educational needs
- Assessing, recording and reporting on students 'readiness to learn', attainment and next step comments as directed by the Leadership Team
- Adopting the 'Falmouth Way' and the 'great teachers toolkit' consistently in to lessons
- Effectively prepare students for internal and external examinations

Additional responsibilities

Be responsible for the preparation and development of teaching materials, teaching programmes and student support arrangements as appropriate.

- Contribute to the faculty's extra-curricular programme as advised by TTL
- Promote the general progress and well-being of individual students and of any class or group of students assigned
- Promote the safeguarding and welfare of students by adopting the schools safeguarding policies, reporting any concerns via 'My Concern'
- Embed the schools praise and conversation policy within all aspects of school, maintaining high standards
- Communicating with the parents of students to provide positive feedback in addition to following the school policies
- Fulfil timetabled duties promptly, enforcing school praise and conversation policies where relevant, whilst maintaining the health and safety of students and staff at Falmouth School
- Attend all calendared meetings and professional development opportunities as directed by the Leadership Team or TTL

- Provide guidance and advice to students on educational and social matters, including information on further education and careers opportunities
- Contribute to reviewing methods of teaching and programmes of work through teaching teams
- Take advantage of professional partnerships within school, to enhance aspects of teaching and reflect on practice
- Identify any professional development needs to TTL and follow the Falmouth School CPD programme as directed by the Leadership Team, keeping up to date with new developments with the curriculum and teaching
- If absent from school (planned or unplanned) provide suitable, appropriate cover for groups
- Fulfil cover of groups whose teacher is not available to teach them, as directed by the curriculum team (rare and in circumstances that are not foreseeable).
- If completing an induction period/ECT year, adhere to the regulations set out
- Participate in the annual cycle of performance management, adhering to targets set

Behaviour and Safety

- Establish a safe, purposeful and stimulating environment for students, rooted in mutual respect and establish a framework for discipline with a range of strategies, using praise, sanctions and rewards consistently and fairly
- Manage classes effectively, using approaches which are appropriate to students' needs in order to inspire, motivate and challenge students
- Maintain good relationships with students, exercise appropriate authority, and act decisively when necessary
- Be a positive role model and demonstrate consistently the positive attitudes, values and behaviour, which are expected of students
- Have high expectations of behaviour, promoting self-control and independence of all learners
- Carry out duties as directed and within the remit of the current School Teachers' Pay and Conditions Document
- Be responsible for promoting and safeguarding the welfare of children and young people within the school and Trust, raising any concerns following school protocol/procedures

Team working and collaboration:

- Participate in any relevant meetings/professional development opportunities at the school/Trust, which relate to the learners, curriculum or organisation of the school including student support arrangements and assemblies
- Work as a team member and identify opportunities for working with colleagues and sharing the development of effective practice with them
- Contribute to the selection and professional development of other teachers and support staff including the induction and assessment of new teachers, teachers serving induction periods and where appropriate threshold assessments
- Ensure that colleagues working with you are appropriately involved in supporting learning and understand the roles they are expected to fulfil
- Take part as required in the review, development and management of the activities relating to the curriculum, organisation and student support functions of the school/Trust
- Cover for absent colleagues within the remit of the current School Teachers' Pay and Conditions document

- Proactively participate with arrangements made in accordance with the Appraisal Regulations 2012

Other:

- To have professional regard for the ethos, policies and practices of the school in which you teach and Trust, and maintain high standards in your own attendance and punctuality
- Perform any reasonable duties as requested by the Headteacher/Chief Executive Officer
- Be aware of, and adhere to, applicable rules, regulations, legislation, policies and procedures within the school/Trust including safeguarding, health and safety and general data protection regulations
- Maintain confidentiality of information acquired in the course of undertaking duties for the school/Trust
