<b>Purpose:</b>	<ul style="list-style-type: none"> <li>To deliver an appropriately broad, balanced, relevant and differentiated curriculum for students and to support a designated department as appropriate.</li> <li>To monitor and support the overall progress and development of students as a teacher/form tutor.</li> <li>To facilitate and encourage a learning experience which provides students with the opportunity to achieve their individual potential.</li> <li>To contribute to raising standards of student attainment.</li> <li>To share and support the school's responsibility to provide and monitor opportunities for personal and academic growth.</li> </ul>

<b>Teaching:</b>	<ul style="list-style-type: none"> <li>To teach students according to their educational needs including the setting and marking of work to be carried out by the students in school and elsewhere. To mark, grade and give written/verbal and diagnostic feedback as required.</li> <li>To assess, record and report on the attendance, progress, development and attainment of students and to keep such records as required.</li> <li>To provide, or contribute to, oral and written assessments, reports and references relating to individual students and groups of students.</li> <li>To ensure that ICT, literacy, numeracy and school subject specialism(s) are reflected in the teaching/learning experience of students.</li> <li>To ensure a high-quality learning experience for students, which meets internal and external quality standards.</li> <li>To prepare and update subject materials.</li> <li>To use a variety of delivery methods that stimulate learning appropriate to student needs and demands of the syllabus.</li> <li>To maintain discipline in accordance with the school's procedures, and to encourage good practice with regard to punctuality, behaviour, standards of work and homework.</li> <li>To undertake assessment of students as requested by external examination bodies, departmental and school procedures.</li> </ul>
<b>Operational / strategic planning:</b>	<ul style="list-style-type: none"> <li>To assist in the development of appropriate specifications, resources, schemes of work, marking policies and teaching strategies in the department.</li> <li>To contribute to the department, its development plan and its implementation.</li> <li>To plan and prepare courses and lessons.</li> <li>To contribute to the whole school's planning activities.</li> </ul>
<b>Management of resources:</b>	<ul style="list-style-type: none"> <li>To contribute to the process of the ordering and allocation of equipment and materials.</li> <li>To assist the Head of Department to identify resource needs and to contribute to the efficient/effective use of physical resources.</li> <li>To co-operate with other staff to ensure sharing and effective use of resources to the benefit of the school, department and the students.</li> </ul>
<b>Curriculum provision and development:</b>	<ul style="list-style-type: none"> <li>To assist the Head of Department in ensuring that the department provides a range of teaching that complements the school's strategic objectives.</li> <li>To assist in the process of curriculum development and change to ensure the continued relevance to the needs of students, examining and awarding bodies and the school's aims and strategic objectives.</li> </ul>
<b>Pastoral system:</b>	<ul style="list-style-type: none"> <li>To be a form tutor to an assigned group of students as required.</li> <li>To promote the general progress and well-being of individual students and of the whole tutor group.</li> <li>To liaise with a pastoral leader to ensure the implementation of the school's pastoral system.</li> <li>To register students, accompany them to assemblies, encourage their full attendance at all lessons and their participation in other aspects of school life.</li> </ul>

<b>Quality assurance:</b>	<ul style="list-style-type: none"> <li>• To help implement school quality procedures and to adhere to those.</li> <li>• To contribute to the process of monitoring and evaluation of the department in line with agreed school procedures, including evaluation against quality standards and performance criteria.</li> <li>• To review, from time to time, methods of teaching and programmes of work.</li> <li>• To take part, as may be required, in the review, development and management of activities relating to the curriculum, organisation and pastoral functions of the school.</li> <li>• To evaluate and monitor the progress of students and keep up-to-date student records as required.</li> <li>• To contribute to the preparation of student action plans and other reports.</li> <li>• To alert the appropriate staff to problems experienced by students and to make recommendations as to how these may be resolved.</li> <li>• To communicate, as appropriate, with the parents of students and with persons or bodies outside the school concerned with the welfare of individual students, after consultation with the appropriate staff.</li> <li>• To contribute to tutorial, careers and enterprise learning according to school policy.</li> <li>• To apply the behaviour management systems so that effective learning can take place.</li> </ul>
<b>Management information:</b>	<ul style="list-style-type: none"> <li>• To maintain appropriate records and to provide relevant, accurate and up-to-date information for EduLink, SIMS, 4 Matrix, registers, etc.</li> <li>• To complete the relevant documentation to assist in the tracking of students.</li> <li>• To track student progress and use information to inform teaching and learning.</li> </ul>
<b>Communications:</b>	<ul style="list-style-type: none"> <li>• To communicate effectively with the parents of students as appropriate.</li> <li>• When appropriate, to communicate and co-operate with persons or bodies outside the school.</li> <li>• To follow agreed policies for communications in the school.</li> </ul>
<b>Marketing and liaison:</b>	<ul style="list-style-type: none"> <li>• To take part in marketing and liaison activities such as open evenings, parents' evenings, review days and liaison events with partner schools.</li> <li>• To contribute to the development of effective subject links with external agencies.</li> </ul>
