Job Description

Job title: Educational Teaching Assistant Inclusive of SEN (SCP 5-6)

PURPOSE OF JOB

To work under the guidance of Teaching/Senior Staff to implement and oversee agreed work programmes with individuals/groups, in or out of classroom. This could include those requiring detailed and specialist knowledge in Early Years Foundation Stage setting.

DUTIES AND RESPONSIBILITIES

- 1. Teaching Support**
- 1.2 To undertake duties in accordance with school practices and procedures, ensuring the job holder actively upholds and promotes the philosophies of the school.
- 1.3 To work under the guidance of the Class Teacher/Line Manager to plan and monitor pupils learning. Ensuring the progress is clearly recorded in the relevant systems and relates to the learning objectives/goals for pupil.
- 1.4 Under the guidance of the Teacher provide one-to-one support to pupils or working with groups of pupils on pre-planned activities, to reinforce the Teacher's approach.
- 1.5 To report to the Teacher any pupil problems or behavioural difficulties in accordance with school policy.
- 1.6 To assist where required in the planning of learning activities.
- 1.7 Under the guidance of the Teacher, ensure equipment or materials are suitable for the learning activities. Prepare materials and teaching aids where necessary.
- 1.8 To participate in and assist in supervision of educational visits, in conjunction with the Teacher/Line Manager.
- 1.9 To assist in classroom and school displays of work.
- 1.10 To undertake routine clerical duties including bulk photocopying etc
- 1.11 Promote good behaviour, dealing promptly with conflict and incidents in line with established policy and encourage pupils to take responsibility for their own behaviour.
- 1.12 To provide specialist knowledge or expertise to support the learning activities of pupils either individually or in a group or within whole classes

2. Pupil Support

- 2.1 To assist with the personal needs of pupils including social, health, physical, hygiene, first aid and welfare matters.
- 2.2 To assist with the supervision of pupils ensuring their safety and access to learning
- 2.3 To actively encourage the inclusion of all pupils to participate in the life and activities of the school and access the national curriculum to the best of their ability.
- 2.4 To provide individual assistance of assistance within groups through implementing behaviour plans, Individual Education Plans and teaching strategies etc, to maximise their achievements.

3. Curriculum Activities

- 3.1 To contribute to the presentation of pupils' work and maintenance of display areas.
- 3.2 To assist with the preparation and tidying of the classroom and upkeep of resources.
- 3.3 To attend and contribute to duty related meetings as required.
- 3.4 To assist in the planning and implementation of structured and agreed learning activities/teaching programmes.

4. General

The above list is not exclusive or exhaustive, and the school may require the job holder to undertake duties commensurate with the level of the role.

- 4.1 Be aware of and support difference and ensure equal opportunities for all.
- 4.2 Contribute to the overall ethos / work / aims of the school.
- 4.3 Appreciate and support the role of other professionals.
- 4.4 Attend and participate in relevant meetings as required.
- 4.5 Participate in training and other learning activities and performance development as required.
- 4.6 Carry out your duties with due regard to current and future School / Trust policies, procedures and relevant legislation.
