# Job Profile: Teaching Assistant

## Job purpose:

• To provide supervision and learning support of students with special educational needs.

## Job specific responsibilities:

- To work under the instruction and guidance of teaching and senior staff to carry out learning, care and support programmes to enable access to learning for students.
- To assist the teacher in the management of students in the classroom or outside the main teaching area on a 1:1 or small group basis
- To supervise students' work and prepare appropriate material for use in the classroom under the direction of the SENCo / Assistant SENCo and/or class teacher.
- To attend to general and specific welfare, social and medical needs relating to students' special needs including programmes to support social, emotional and mental health provision and oversee specific educational programmes and activities.
- To undertake a range of tasks in support of students' undertaking internal and external examinations.
- To record aspects of student learning and achievement as required and in accordance with school policies and procedures.
- To monitor, track and update learning plans, pupil passports and provision maps for key students.
- Support the school in other aspects of operations including tasks related to:
  - o Student welfare, discipline and learning
  - o Faculty and department general operations
  - o Professional standards within the setting
- Supervise students eating/leisure at break times and lunch times. Post holders breaks and lunches to be taken flexibly.
