## Job Description

### Main purpose

- To assist in promoting the learning, behaviour and personal development of the pupil to whom you are assigned to enable him/her to make the best use of the educational opportunities available to them.
- To supervise and provide in depth support for a pupil with special educational needs, to promote independence, inclusion, acceptance and equality of access to learning opportunities
- To provide in and out of class support to implement de-escalation strategies and the reduction of risk and restraint.
- To create and maintain a purposeful, orderly and supportive environment in accordance with lesson plans and to support predefined learning activities to meet the needs of the pupil and curriculum
- To liaise with SENDCo, class teacher and other professionals about learning plans, contributing to the planning and delivery as appropriate
- To monitor, feedback, record and report on pupil progress
- To consistently and effectively implement agreed behaviour management strategies and procedures at the school
- To build and maintain positive and constructive working relationships with the pupil, parents, carers and colleagues to maximise pupil development.
- To support the pupil in the development of their social skills and behaviour by providing them with appropriate role models.
- To support teaching staff and pupils and visits, trips and out of school activities as required.
- To participate in review meetings as required.

### Duties and responsibilities

#### Teaching and learning

- Demonstrate an informed and efficient approach to teaching and learning by adopting relevant strategies to support the work of the teacher and increase achievement of all pupils including, where appropriate, those with special educational needs and disabilities (SEND)
- Promote, support and facilitate inclusion by encouraging participation of all pupils in learning and extracurricular activities
- Use effective behaviour management strategies consistently in line with the school's policy and procedures
- Support class teachers with maintaining good order and discipline among pupils, managing behaviour effectively to ensure a good and safe learning environment
- Organise and manage teaching space and resources to help maintain a stimulating and safe learning environment
- Observe pupil performance and pass observations on to the class teacher
- Supervise a class if the teacher is temporarily unavailable
- Use ICT skills to advance pupils' learning
- Undertake any other relevant duties given by the class teacher

#### Planning

- Contribute to effective assessment and planning by supporting the monitoring, recording and reporting of pupil performance and progress as appropriate to the level of the role
- Read and understand lesson plans shared prior to lessons, if available
- Prepare the classroom for lessons

## **Working with colleagues and other relevant professionals**

- Communicate effectively with other staff members and pupils, and with parents and carers under the direction of the class teacher
- Communicate their knowledge and understanding of pupils to other school staff and education, health and social care professionals, so that informed decision making can take place on intervention and provision
- With the class teacher, keep other professionals accurately informed of performance and progress or concerns they may have about the pupils they work with
- Understand their role in order to be able to work collaboratively with classroom teachers and other colleagues, including specialist advisory teachers
- Collaborate and work with colleagues and other relevant professionals within and beyond the school
- Develop effective professional relationships with colleagues

## **Whole-school organisation, strategy and development**

- Contribute to the development, implementation and evaluation of the school's policies, practices and procedures, so as to support the school's values and vision
- Make a positive contribution to the wider life and ethos of the school

## **Health and safety**

- Promote the safety and wellbeing of pupils, and help to safeguard pupils' well-being by following the requirements of Keeping Children Safe in Education and our school's child protection policy
- Look after children who are upset or have had accidents
- Administer basic first aid if needed

## **Professional development**

- Help keep their own knowledge and understanding relevant and up-to-date by reflecting on their own practice, liaising with school leaders, and identifying relevant professional development to improve personal effectiveness
- Take opportunities to build the appropriate skills, qualifications, and/or experience needed for the role, with support from the school
