OVERALL PURPOSE OF JOB

Support teaching and learning by working with individual students or small groups of students, under the direction of the teacher, SENCo or other colleagues.

MAIN DUTIES AND RESPONSIBILITIES	
1	Under direction and guidance, work with individual students or small groups of students as directed, to implement planned learning activities
2	Support students in class as and where required, under the direction of the class teacher
3	Participate in the planning and evaluation of learning activities, adapting work and activities as directed
4	Assist with the assessment and monitoring of student progress by providing feedback on students' achievements and progress, including keeping accurate records
5	Assist with the development of individual plans for students by providing feedback
6	Support students with their personal and social development
7	Provide information and attend meetings with staff, parents/carers and other external professionals as and when required, under the guidance of the class teacher, SENCo or member of SLT
8	Understand and support independent learning and inclusion of all students
9	Accompany other staff and students on school visits, trips and in other activities outside of the classroom, taking responsibility for specific students or small groups as directed
10	Undertake routine administrative and clerical tasks as and when required
11	Assist students with eating, dressing and personal hygiene where required, whist
