OVERALL PURPOSE OF JOB
Support teaching and learning by working with individual pupils or small groups of pupils, under the direction of the teacher, SENCo or other colleagues.

MAIN DUTIES AND RESPONSIBILITIES	
1	Under direction and guidance, work with individual pupils or small groups of pupils as directed, to implement planned learning activities
2	Support pupils in class as and where required, under the direction of the class teacher
3	Participate in the planning and evaluation of learning activities, adapting work and activities as directed
4	Assist with the assessment and monitoring of pupil progress by providing feedback on pupils' achievements and progress, including keeping accurate records
5	Assist with the development of individual plans for pupils by providing feedback
6	Support pupils with their personal and social development
7	Provide information and attend meetings with staff, parents/carers and other external professionals as and when required, under the guidance of the class teacher, SENCo or member of SLT
8	Understand and support independent learning and inclusion of all pupils
9	Accompany other staff and pupils on school visits, trips and in other activities outside of the classroom, taking responsibility for specific pupils or small groups as directed
10	Undertake routine administrative and clerical tasks as and when required
11	Assist pupils with eating, dressing and personal hygiene where required, whilst also encouraging independence



12	May be given areas of responsibility within the school that are appropriate to specific skills, knowledge and experience, for example in maintaining curriculum resources in a particular subject area, preparing displays, etc.
