- ➤ Promote, support and facilitate inclusion by encouraging participation of all pupils in learning and extracurricular activities
- > Use effective behaviour management strategies consistently in line with the school's policy and procedures
- Support class teachers with maintaining good order and discipline among pupils, managing behaviour effectively to ensure a good and safe learning environment
- > Organise and manage teaching space and resources to help maintain a stimulating and safe learning environment
- ➤ Observe pupil performance and pass observations on to the class teacher
- ➤ Supervise a class if the teacher is temporarily unavailable
- ➤ Use ICT skills to advance pupils' learning
- ➤ Undertake any other relevant duties given by the class teacher

Planning

- Contribute to effective assessment and planning by supporting the monitoring, recording and reporting of pupil performance and progress as appropriate to the level of the role
- > Read and understand lesson plans shared prior to lessons, if available
- > Prepare the classroom for lessons

- Communicate their knowledge and understanding of pupils to other school staff and education, health and social care professionals, so that informed decision making can take place on intervention and provision
- ➤ With the class teacher, keep other professionals accurately informed of performance and progress or concerns they may have about the pupils they work with
- ➤ Understand their role in order to be able to work collaboratively with classroom teachers and other colleagues, including specialist advisory teachers
- > Collaborate and work with colleagues and other relevant professionals within and beyond the school
- > Develop effective professional relationships with colleagues

Whole-school organisation, strategy and development

- Contribute to the development, implementation and evaluation of the school's policies, practices and procedures, so as to support the school's values and vision
- Make a positive contribution to the wider life and ethos of the school
