Core Purpose

To assist in the teaching, delivery and maintenance of the Design and Technology, Horticulture and Art

To support any aspects of teaching and learning in the Technology, Horticulture and Art department, as required.

Main Responsibilities

The responsibilities of this role could vary as a result of new legislation, changes in technology or policy changes. This job description is not an exhaustive list of tasks of the role.

Supporting teaching staff within the classroom with the preparation and tidying of resources and helping with small group work.

Preparation and maintenance of resources for lessons, e.g. Range of hand tools and some basic machinery

Monitor resources, including storage of materials, checking deliveries, identifying replacement of consumables and arranging servicing of equipment.

Working with CAD/CAM using a 2D Design to assist pupil work.

Carry out minor repairs to equipment and tools. E.g., sharpening chisels, repairing leads, cameras.

Carry out visual and other routine safety checks in compliance with the Health and Safety policy and legislation.

Maintain Inventory of equipment as appropriate.

Maintain a safe working environment.

Preparation of materials and prototypes. E.g., practical models

To provide support for any other administrative role within the Academy, as and when required.

Responsible for the health, safety and welfare of themselves and others

Responsible for the safeguarding and promotion of the welfare of children

To be a team player, and contribute towards the Academy vision, within own capabilities

The post-holder may, from time to time, be required to carry out other duties commensurate with the role.
