Duties and Responsibilities

As the Trust Finance Manager, you will be an integral part of the team responsible for ensuring high standards of financial integrity across the Trust. You will manage the monthly financial processes required of the academies, ensuring compliance with the requirements of the Academies Trust Handbook, play a significant part in the financia planning and partner with the Headteachers and other senior staff to ensure effective strategic decision making.

This role will work closely with schools within the Trust, helping to identify best practice and implement new standardised processes and procedures.

Core Responsibilities

- Ensure timely production and issue of financial reports, cash flow forecasts and returns as required.
- Prepare the monthly management accounts.
- Prepare the monthly financial reports, analysis and updates.
- Prepare the annual budget and forecasts for approval by the Trust Board.
- Take responsibility for the academy's accounting procedures, ensuring all policies and procedures are adhered to within the Trust.
- Maintain finance filing systems, ensuring that records are suitable for audit purposes.
- Work with the Chief Finance & Operating Officer to ensure goods and services are processed in compliance with current and relevant procurement legislation.
- Partner with the Headteachers and other senior staff to ensure effective financial management, adherence to budget and strategic decision making.
- Drive forward change and initiatives which promote regularity, propriety, value for money and best standards.
