JOB DESCRIPTION

JOB SUMMARY:

To contribute to the development of a strong, effective school with an emphasis on promoting a culture of educational excellence, within a caring and secure Islamic environment enriched with the values of discipline, mutual care and respect which extends beyond the school into the wider community.

JOB PURPOSE:

1. Support and assist the Principal by providing dynamic instructional leadership and management by sharing and modelling the school's vision and values in everyday work and practice.
2. Work with the Principal and other Star leaders to ensure the very best education for the students, through achieving the organisation's aims and objectives. In particular, to develop and manage curriculum, teaching and learning policies.
3. Lead the implementation of Star pastoral systems to secure high levels of attendance and outstanding behaviour.
4. Ensure a consistent and continuous focus on students' achievement, with systems for recording individual student's progress, and effective use of data and benchmarks to monitor progress in every student's learning.
5. Develop and maintain high quality transition from primary schools, with curriculum continuity and maximised student progress.
6. Make sure parents and students are well informed about the curriculum, attainment and progress.
7. Undertake any professional duties delegated by the Principal and carry out the professional duties of the Principal in the event of their absence.

KEY RESPONSIBILITIES AND ACCOUNTABILITIES TO BE CARRIED OUT IN CONJUNCTION WITH THE PRINCIPAL

1. Overall Strategic Responsibilities

- 1.1 Work in partnership with the Principal, Senior Leadership Team, Local Accountability Board, staff, students, parents and the Trust in generating the ethos and values which underpin the school enriched by mutual care and respect extending into the local community.
- 1.2 Support the maintenance and enhancement of the school's ethos and mission through own outstanding professional conduct and high expectations of others.
- 1.3 Provide outstanding strategic and operational leadership of all areas of responsibility.

- 1.4 Develop and implement an effective strategy for all areas of responsibility in collaboration with other members of the Senior Leadership Team.
- 1.5 Devise and implement a development plan for all areas of responsibility with clear annual targets agreed with all members of the Senior Leadership Team.
- 1.6 Performance manage all staff with respect to all areas of responsibility for students; through regular meetings, setting of appropriate targets for performance, providing support and challenge and undertaking regular reviews for feedback.
- 1.7 Develop systems and structures for the effective management and administration of all areas of responsibility.

SUPPORT AND LINE MANAGE THE ASSISTANT PRINCIPAL: TEACHING AND LEARNING

2. Quality of Learning and Teaching, Monitoring and Assessment

- 2.1 Lead the development and implementation of QAP systems to ensure effective planning, assessment, monitoring and recording, learning and teaching and attainment in all curriculum areas.
- 2.2 Develop and implement strategies for enhancing learning and teaching to ensure all lessons are 'good' or 'outstanding'.
- 2.3 Reinforce and monitor the adherence of all staff towards school initiatives around learning and teaching and classroom management.
- 2.4 Organise and implement a termly observations programme.
- 2.5 Provide leadership of the development and regular meetings of a Learning and Teaching Group to develop and disseminate good practice across school.
- 2.6 Provide strategic leadership and manage the promotion and development of personal, learning and thinking skills across the school.
- 2.7 Lead the introduction and implementation of innovative technologies to enhance learning and teaching.

3. Professional Development

- 3.1 Lead the organisation and delivery of 'Training and Planning Days' and professional development sessions to enhance learning and teaching practice.
- 3.2 Provide strategic leadership and management of the professional development of staff.
- 3.3 Lead the development and implementation of coaching plans to ensure all staff deliver 'good-to-outstanding' lessons.
- 3.4 Identify particular development needs in individual staff and provide coaching to address these.
- 3.5 Support the induction of new staff to ensure that there is consistency in the delivery of learning and teaching and classroom management strategies.
- 3.6 Provide the strategic leadership of statutory performance management target-setting and review across the whole organisation.
- 3.7 Manage the statutory induction of newly qualified staff and mentoring of unqualified staff.

SUPPORT AND LINE MANAGE THE ASSISTANT PRINCIPAL: ACCESS AND INCLUSION

4. Pastoral

- 4.1 Provide line management of the Pastoral team, supporting and challenging them to achieve all targets.
- 4.2 Devise and lead implementation of a pastoral development strategy.
- 4.3 Develop and lead implementation of strategies to enhance transition arrangements for new students.
- 4.4 Develop and lead implementation of strategies to sustain the highest levels of attendance, punctuality and standards of behaviour, including an effective rewards and sanctions system.
- 4.5 Develop strategies to ensure the effective safeguarding of children.
- 4.6 Develop and implement a Healthy Schools strategy, including effective liaison with external agencies.
- 4.7 Manage the student, staff and parent councils.
- 4.8 Lead the delivery of an 'Every Child Matters' Group to enhance and sustain a bespoke programme of support for learners at-risk in relation to safeguarding, behaviour and attendance.

5. Mentoring Programme, Well-Being and Emotional Intelligence

- 5.1 Develop and implement strategies to enhance the social, emotional and pastoral development of learners.
- 5.2 Develop and manage a programme of mentoring and counselling vulnerable students.
- 5.3 Develop and implement a programme of initiatives that develop learner and staff spirituality.
- 5.4 Develop and promote strategies for securing effective parenting, with particular reference to the safe use of ICT by learners.
- 5.5 Develop and deliver programmes for assembly and registration.

6. Personalised Learning and Special Educational Needs

- 6.1 Provide line management of the Assistant Principal: Access and Inclusion, supporting and challenging the team to achieve all targets.
- 6.2 Develop and lead implementation of strategies to enhance provision for G & T and SEN students.
- 6.3 Lead the completion of provision mapping.

7. Faculty Management

- 7.1 Provide line management to the Directors of Learning for designated faculties, supporting and challenging them to achieve faculty targets.
- 7.2 Audit all curriculum areas in the designated faculties to ensure statutory compliance, proficient standards of provision, the highest levels of attainment and effective systems and structures.
- 7.3 Support Directors of Learning to enhance assessment for learning and develop more effective curricula in each of the faculties.

8. Careers and Information, Advice and Guidance

- 8.1 Provide line management of the Careers and Enterprise section of the school, supporting and challenging them to achieve all targets.
- 8.2 Develop and lead implementation of strategies to provide effective careers guidance to all students.

- 8.3 Provide overall leadership for the provision of work experience placements.
- 8.4 Develop and manage a programme of enhanced information, advice and guidance for all students.

9. Leadership Enrichment

- 9.1 Lead the development and delivery of the school's leadership specialism.
- 9.2 Lead the organisation and management of a 'Sports' and 'outdoor pursuits' programme to be delivered outside of school hours.
- 9.3 Lead the organisation and delivery of the 'leadership days', 'specialist days' and leadership-related activity, within and beyond the curriculum.
- 9.4 Lead the organisation and delivery of a programme for 'community service' and charitable giving, liaising effectively with partners such as Star Academies Charity.
- 9.5 Lead the development and management of the 'Star Academies Bacc' programme.

10. Communication and Administration

- 10.1 Provide leadership of the communication of staff briefing notes on a weekly basis.
- 10.2 Manage the delivery of the school calendar.
- 10.3 Manage the delivery of the staff handbook.

11. Relationships with Others

- 11.1 Participate in the Performance Management Cycle and INSETs.
- 11.2 Participate in the induction of new staff into the school community.
- 11.3 Maintain good working relationships with colleagues, students, parents/carers, governors, the community and Trust and ensure all communication is consistent with the school's ethos.

12. Accountability

- 12.1 Make best use of all resources to support the attainment of students.
- 12.2 Ensure that parents/carers and students are well informed about the curriculum, attainment and progress and about the contribution they can make in supporting their child's learning.

13. Other Responsibilities

- 13.1 Lead on the promotion, dissemination, implementation and monitoring of all whole-school strategies.
- 13.2 Promote the Trust's vision of 'nurturing today's young people, inspiring tomorrow's leaders'.
- 13.3 Champion the Trust's values of 'Service', 'Teamwork', 'Ambition' and 'Respect'.
- 13.4 Contribute to the wider life of the Trust and the Star Academies community.
- 13.5 Carry out any such duties as may be reasonably required by the Trust.

14. Records Management

- 14.1 All staff who create, receive, and use records in the course of their job are responsible for ensuring that records are managed appropriately. It is therefore likely that this post-holder will have responsibility for record-keeping as part of the role. Employees are required to be conversant with the Trust's policies and procedures on records management.
